## Conditions



1. The on the front side stated member has to make sure that his/her contribution fee can be withdrawn from his/her bank account within 2 months.
2. The on the front side stated member has to possess a valid Campus- or Union Card with the association fee.
3. If the on the front side stated member does not meet terms 1 and/or 2, the board of S.K.V. Vakgericht will be necessitated to take actions. The club therefore will charge all the resulting extra costs to the on the front side stated member.
4. By signing this form, the on the front side stated member accepts the stated conditions and obligates itself to pay the contribution for every college year in which he/she will be a member.
5. If a member wants to sign out at S.K.V. Vakgericht, he/she has to write a letter/e-mail after which he/she will receive a written confirmation from the board of the association.
6. If a member does not sign out before August 1<sup>st</sup> of the current college year, he/she will automatically stay a member for the next year.
7. The privacy statement of S.K.V. Vakgericht is applicable on this form. The privacy statement can be found on [www.vakgericht.nl](http://www.vakgericht.nl).

### Provisions concerning the withdrawal:

- If necessary, the withdrawals will be every first week of the month.
- Every month there is a maximum of €75,- that may be withdrawn from the bank account of the member.
- There may be withdrawals for contribution fee, costs for activities participated in and for bought goods.
- The member has the right to make a remark about the amount of money that will be withdrawn. He/she will have to make this remark at least one week before it will be withdrawn.
- The authorisation will be valid until 2 months after sign out.

### Notes:

- The academic year starts at September 1<sup>st</sup> and ends at August 31<sup>st</sup>.
- S.K.V. Vakgericht uses working duty (Dutch: "werkheffing"), the member doesn't have to pay this if he/she satisfies the conditions of the exemption of the working duty.
- Working duty (Dutch: "werkheffing") is a kind of labour that is mandatory for every member or can be bought off. The amount of working hours and the fee will be determined every year during a general members assembly.
