#### Conditions membership Studenten Korfbal Vereniging Vakgericht:

1. The signatory declares to abide by the obligations arising from the membership as stated in the Statutes and the Rules of Procedure of student korfbal association Vakgericht.
2. By signing this document, the signatory declares that he / she agrees with the Privacy Statement. The Privacy Statement can be found on the website [www.vakgericht.nl](http://www.vakgericht.nl)
3. When registering, a member subscribes for a period of one year, unless stated otherwise.
4. The member must be in possession of a valid Unioncard or Campuscard during the entire membership and must pay the subsequent obligation to pay the association fee for Vakgericht. If the member fails to do so, Vakgericht will recover all resulting costs from the member.
5. The membership is only terminated when the member has submitted a written statement with date and signature, or has sent an e-mail to the secretary.
6. The season ends on the 31<sup>st</sup> of August. If the written statement or e-mail mentioned under point 4 is not received at this moment, it is assumed that the membership continues during the next season.
7. If the written statement or e-mail mentioned in point 4 is received after the 31<sup>st</sup> of August, the half-year contribution will have to be paid.
8. Vakgericht uses a 'werkheffing' which the signatory only has to pay if the signatory does not meet the conditions for the exemption from the 'werkheffing'. The amount of working hours and the costs for not achieving the 'werkheffing' are determined each year during a general meeting. The amount of working hours and the costs for not achieving this can be found on the website [www.vakgericht.nl](http://www.vakgericht.nl).

#### Provisions concerning direct debit:

1. Money will, if necessary, be deducted in the first week of the month.
2. There is a maximum amount of €75 per month that may be debited from the account of the signatory.
3. The signatory is entitled to an overview of costs for the month on which the invoice is being debited. The signatory will receive the overview at least two weeks before the amortization date.
4. Up to 30 days after the date of debit, the signatory can object to the collection and can the objection be reversed.
5. The authorization can be terminated at any time by means of a written statement, provided with the date and signature, addressed to the treasurer. The authorization remains valid for up to 6 months after the termination of the membership.
